Pursuant to Regulation-30 read with Schedule-III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this to inform you that the Board of Directors of the Company in its meeting held on date, 7.1.2017 has unanimously approved the following :

1. To acquire entire share capital of Jiwanjyoti Vanijya Private Limited and make it a wholly owned subsidiary of the Company.
2. To acquire entire share capital of Glitter Agencies Private Limited and make it a wholly owned subsidiary of the Company.
